The County may cancel this Agreement at any time upon discovery that any of the information set forth above is inaccurate, that these terms have been violated.

## Funds disbursement and Reporting requirements Acknowledgement

- If awarded, County Parks will provide funds in two installment payments, forty percent (40%) within thirty (30) days of receiving a Payment Request #1 after proposal is approved and the contract is fully executed, and the remaining sixty percent (60%) upon the acceptance of a Final Project Report and Payment Request #2. It is understood that final reports for payment must be submitted to the Department by July 14, 2026.
- Funds should be used solely for the designated purposes as described in the executed Agreement and subject to Grantee's performance of all requirements under the Agreement.
- Final Program Report shall include the following materials: documentation of activities offered (e.g., activity calendar, program flyers, photographs, etc.) and attendance figures.
- In addition, the awardee shall acknowledge in all reports and literature, as well as on the agency website, that the County of Santa Cruz Parks, Open Space and Cultural Services has provided funding for proposed program.
