Subject: Aquatics Section Report

Since the beginning of the year, the Aquatics section has been active delivering a wide range of programs and certifications. We have provided swim lessons to 273 participants, continuing to focus on water safety and skills for all ages. In addition, we hosted two Junior Guard Clinics, designed to prepare participants to pass our swim test, with 119 participants involved. We launched our first-ever Spanish swim lesson session, broadening our outreach to the Spanish-speaking community. Another session of Noodleball was hosted, with 22 participants, and we are hopeful to start a Noodleball league in the future with such high demand for this program.

We are excited to offer our new Spring Break camp, which has 30 participants enrolled and another 30 on the waitlist. On April 1st, we opened registration for our Summer programs, offering a total of 672 participant spots, the most we have ever offered. Junior Guard camps reached full enrollment in their first two AM and PM sessions. Little Guards has full enrollments for all sessions throughout the Summer.

For the first time, we also offered a Lifeguard Instructor (LGI) course, certifying 4 new Lifeguard Instructors. Furthermore, we sent two team members out of the county for additional training, which has led to the addition of a new Water Safety Instructor and a Lifeguard Instructor Trainer to our team.

Throughout all of our successful programming, we have continued to maintain a great, safe, and beautiful swim facility that remains open seven days a week, offering lap swimming and a warm therapeutic pool to the community. We have three swim teams that rent lanes each evening, we offer Adult Fitness, Water Aerobics, and Dominican PEP classes throughout the week.

Subject: Maintenance Section Report

#### **North County**

- The Pollinator Garden at Felton Discovery Park is currently being restored to rejuvenate the garden's
  natural beauty while enhancing its role as a vital habitat for bees, butterflies and other pollinators
  restoring local biodiversity.
- Along the discovery loop trail at Quail Hollow Ranch work is being done to restore the sensitive Sand Hill habitat which is a unique ecosystem with several endemic species.
- Work at the Anna Jean Cummings Park athletic fields is being done to upgrade playing surfaces and enhance usability.
- Access to natural spaces is also being expanded. The Pace Family Wilderness trail project is being established which will open opportunities for connection and exploration.
- Landscaping around the new playground at Floral County Park is creating a more inviting and family-friendly atmosphere, blending natural beauty with safe and engaging play areas.

#### Mid County

- In late March, the Simpkins Family Swim Center was closed for a dedicated pool maintenance day, involving deep cleaning and general repairs to ensure the facility remains safe, clean and enjoyable for swimmers of all ages.
- The new Felt Street Office and Maintenance Shop is currently undergoing a conversion to repurpose
  the existing space into a functional office and shop, enhancing efficiency for parks staff and service
  delivery.
- The Felt Street Park restrooms were vandalized again. Maintenance staff made timely repairs to reopen clean and accessible facilities.
- Jose Avenue turf renovations and tree work were completed to enhance the park's natural beauty and improve its functionality for recreational use.
- Brommer Park Baseball field renovations were completed, upgrading the playing surfaces and drainage for improved play and safety.

#### **South County**

- Via Palo Alto coastal access deck underwent construction to help ensure a healthy, open space for the community to enjoy.
- At Seascape County Park, a donated spring rider was installed in the playground making it more enjoyable for a broader group of children.
- Seasonal mowing was done at The Farm Park and Freedom Annex to maintain these spaces and keep them usable throughout the year.

- Aptos Polo Grounds had upgrades to its irrigation systems, enhancing the quality of the fields and ensuring they remain in excellent condition for sports and events.
- Scott Park is undergoing Acacia tree removals to maintain safety and improve the overall health of the landscape.
- Pinto Lake continues to see fieldwork aimed at improving park facilities and overall park health.

## **General Maintenance**

- Lots of spring weed whipping and landscaping this time of year to keep various sites clean and presentable to the public.
- Training newly hired Maintenance Worker I staff ensuring that the team is well-equipped to handle the ongoing needs of the County Parks facilities.
- General drainage and storm maintenance is an ongoing priority, addressing water management issues to ensure that parks remain accessible and safe.

#### **Coastal Rail Trail**

Segments 10 and 11: The project team has spent the last two months coordinating with the City of Capitola to seek City Council support for a trail alignment along the southern edge of Park Avenue between Monterey Ave and Grove Lane. The Park Avenue alignment would replace the original design for a trail on the coastal side of the tracks through this area. The Park Avenue alignment has multiple benefits including reduced construction cost, better neighborhood connectivity, increased safety along Park Avenue and alignment with the City of Capitola's Park Ave Traffic Calming project goals, better ocean views, and would be further from the eroding coastal bluff. The City Council declined to vote on the Park Avenue alignment when County staff presented it to them at the February 13 City Council meeting and requested additional information on the project at a Town Hall event. At the request of the Capitola City Council, County, RTC, and City staff held a City-hosted Town Hall on April 2 to discuss the overall Segment 10/11 project, the Park Ave alignment, the project's plan to route trail users through the Village, and implications of Measure L for development of the Segment 10/11 project. The future use of the Capitola Trestle for a trail and/or the future replacement of the Trestle as part of passenger rail, as well as details on the RTC's Zero Emission Passenger Rail and Trail project were also discussed. The City Council is expected to make a decision on the Park Ave alignment at a special City Council meeting on April 17.



City Council direction on the Park Ave alignment is needed prior to determining a final design scope of work with the consultant team. An amendment to the existing consultant contract to add final design will go to the Board for approval on April 29. Additional environmental review of the Park Ave alignment is needed since the alignment was not included in the project's EIR. Should City Council support moving forward with the Park Ave alignment, a second consultant contract amendment to add environmental review of the Park Ave alignment will also go to the Board on April 29. Environmental review would be conducted over the summer, and the entire project would return to City Council in Fall for approval of the entire project and issuance of permits. Should City Council not support moving forward with the Park Ave alignment, the project team would seek RTC support for pursuing the coastal alignment, despite the increased costs and conflict with future passenger rail. Final design for the project will kick-off after approval of the contract amendment, and will start by modifying the design to incorporate suggestions from the RTC-led value engineering study conducted in 2024. Updated designs and cost estimates for the project are expected in late Summer.

Ecology Action is continuing to lead the non-infrastructure programming portion of the project, coordinating with 10 area schools on bicycle and pedestrian education classes, and the creation of a community incentive program that will target low-income monolingual Spanish speaking residents of Live Oak, Pleasure Point, and Capitola. Additional pedestrian and bicycle classes at area schools are scheduled for 2025.

North Coast Rail Trail (Segment 5): The RTC expects to open the Panther/Yellowbank parking lot to the public this summer prior to the rest of the project opening in Summer 2026. The early opening of the parking lot is a permit requirement for the project in order to minimize impacts to public coastal access. The trail itself will not be open. As part of the Maintenance Agreement for the project, County Park and Public Works will be maintaining the trail on behalf of the RTC. An addendum to the Maintenance Agreement will need to be approved by the Board of Supervisors and RTC to have Parks staff begin early maintenance of the parking lot.

## Floral County Park Playground Renovation

Site work, drainage modifications and landscape modifications have been completed; play structure and PIP have been installed. The project was completed in Winter 2024. Through volunteer effort, Parks is currently working on the implementation of a pollinator garden within the planting areas in the playground areas. The Public Art piece will be finished in Spring 2025.










#### **Freedom Lake Restoration Plan**

Freedom Lake, a cherished natural resource for both wildlife and the community, has faced challenges from invasive species that disrupt native habitats and diminish water quality. In a series of workday events, dedicated teams from Watsonville Wetlands Watch and the California Conservation Corps worked side by side to remove invasive trees and plants that are impairing native habitat and obstructing the open viewing and access routes of park users. Consistent with best practices for riparian habitat and vegetation management, willow trees were pruned and limbed up to reduce hazards for park users and enhance lines of site and the feeling of openness to enhance park user safety. During the winter rains approximately 100 native understory plants and shrubs are being planted within the Acacia removal areas to increase diversity of native plants growing on site and improve the park user experience. Phase 2 for this project, including a series of planning studies and analysis will be performed in coordination with staff from Santa Cruz County Parks and other resource professionals in the region, is expected to commence in late Spring 2025.





## **Greyhound Rock**

Parks staff are finalizing consultant contracts to conduct an initial feasibility study that will analyze the potential for biological, geological, and cultural constraints on the for the cabin project. This feasibility study will identify suitable development locations for the environmental education center and cabins. Results of the initial feasibility study are expected in Late Summer 2025.

#### **Hidden Beach County Park**

Site Prep Work for construction of the project started in January. The permanent, prefabricated, ADA-compliant double-unit restroom was delivered on-site on February 26th. Site Work including final utility connections, parking lot modifications, ADA path of travel and landscape modifications are currently undergoing. The project is expected to be completed in Spring 2025.






#### **Moran Lake County Park**

Monarch Butterfly Habitat Management Plan: A draft of the wind study was provided by the consultant team at the end of March. Parks will schedule a community meeting to discuss results of the wind study and next steps likely in May.

#### **Pace Property Connection Trails**

Pace Property Trails will bring residents through the sandhill habitat, one of the rarest ecosystems in the United States and found only in Santa Cruz County. Project trail layout and flagging have been completed with great interest from the community. Park staff have coordinated directly with the biologist and trail design consultant in refining the trail layout. Park staff and the project biologist have collaborated in creating the worker environmental awareness training program. The training is required for all workers and volunteers associated with



construction on the trail and was held in February. The topics covered were construction best management practices, and biological resource protection measures, including the special status species that reside in the sandhill habitat. The project biologist has submitted the permitting requirements for the project with U.S. Fish and Wildlife Service. Trail construction will be a coordinated effort between Parks staff, the trail design crew, and local volunteers. With an estimated volunteer percentage of 35%-45% for the trail construction. Trail construction will have to occur outside of the Mount Hermon June beetle flight season from May 15 to August 15, and bird nesting survey will be performed prior to the spring construction. Parks Department will be working with an AmeriCorps team late spring to clear invasive broom and begin construction on the loop trail.





## Santa Cruz Coastal Lagoons & East Cliff Drive Resiliency Study

County Parks was awarded a \$650,000 grant from the State Coastal Conservancy to develop an initial planning-level feasibility study of nature-based adaptation strategies to sea level rise for East Cliff Drive at the three coastal lagoons (Schwan Lagoon, Corcoran Lagoon, and Moran Lagoon) in mid-Santa Cruz County. The goal of the project is to identify a preferred adaptation strategy for each location that prioritizes nature-based solutions, protection of coastal resources and ecosystems, maintenance of coastal access, and protection of

infrastructure and property.

An RFP for consultant support for the project was released on January 6. The County received three proposals from highly qualified consultant teams. A selection committee comprised of staff from the Coastal Conservancy, California State Parks, County Public Works, and County Parks evaluated the proposals, conducted reference checks, and interviewed the consultant teams and selected Environmental Science Associates (ESA) as the top-ranked consultant team. The County will begin negotiations on scope and fee with the top-ranked consultant team, and if those negotiations are successful, staff expects to bring a contract to the Board for approval in May.

## South County Parkland Acquisition - Whiting Road

A preliminary park diagram for phase 1 was developed by County Parks while a permanent plan is developed. The diagram was shared previously with the Commission. Funds have been allocated for phase 1 implementation and staff are coordinating required access improvements to scope out the Phase 1 work. Partial funding for Master Plan development has been allocated from the District 4 Supervisor's office, and staff will begin work on an RFP to select a consultant team for the effort.

## Partnerships with Local Recreation Departments

- The SC County Parks Department collaborated with magazine Growing Up in Santa Cruz at the Capitola Mall - Museum of Discovery on Saturday, March 22<sup>nd</sup>. The event efforts were to promote preschool/teens, health and fitness, summer activities and identify resources to the over 150 people who attended the event.
- County Parks Friends hosted its Career Day at Simpkins Family Swim Center on Saturday, March 29<sup>th</sup>.
   County staff provided information for current and upcoming openings to youth who live in the Live Oak area.
- Santa Cruz County Parks Department is planning its next Family Fun Day event. The event is going to be held on July 19<sup>th</sup> in Scotts Valley. Meetings continue taking place with local recreational agencies (Watsonville, Capitola, Santa Cruz, Scott's Valley and SC County) for the planning and implementation of the upcoming event.
- Recreation staff provided a youth late night program for the Mar Vista Elementary Parent Club on Friday, March 21<sup>st</sup>. The program took place at Aptos Village Park from 5-10pm and served youth from the Mar Vista Elementary school.
- Recreation team attended a Job Fairs/Career Day with Your Future Is Our Business organization to maximize exciting job opportunities awareness for the students at San Lorenzo Valley High School.

#### **Recreation Programs & Contractual Agreements**

- The recreation team extended its contract with Live Oak School District Del Mar Elementary school for an additional 10 dates. Staff will visit the school on Fridays from 2-4pm to work with sixty (60) 5<sup>th</sup> and 6<sup>th</sup> grade students in cognitive thinking, promoting team building, health and wellness and Outdoor Education activities.
- The Recreation team secured two (2) contracts
  - Santa Cruz Group Open Air Training (GOAT) to offer sessions during the summer.
  - Skatedogs will be offering three (3) skateboarding camps at the Seacliff Skate Park during the summer months where youth will make new friends, learn new skills and more importantly have fun and hopefully fall in love with a new sport.
- Our active adult programs continue to offer the following FREE recreational activities for community members through the partnership with the Capitola Mall:
  - Mall Walking
  - Stretching Class
  - o Bridge Club

- Tai Chi In March, 22 participants engaged in an 8 class Tai Chi session offered at SFSC Community Room. The Tai Chi community has continued to grow with a full class each session since June 2023. The program will take a break this summer and will resume in the fall with a fee.
- Active Adults took a fee-based field trip to the City of San Jose and started the day with lunch at San Pedro Square. After lunch the group headed to San Jose Center of the Performing Arts for the Broadway "The Cher Show". The group enjoyed themselves and Cher fans danced and sang throughout the performance.

#### Mobile Recreation

We are visiting a different County Park each month and bringing a free activity plus snack for Mobile Rec Mondays. We had a variety of Sports plus chicken hot dogs at Mesa Village in March. This month, April 14, we are back at Felton Covered Bridge. Come stop by to say hi and play with us between 3:30-5:30 to find out which activity and snack we will have this time!

#### Field Trips

- We hosted our first two field trips of 2025 over the past few weeks at Quail Hollow Ranch! Students learned how to do Nature Journaling using words, pictures, and numbers, and explored animal and plant adaptations while making connections. Participants utilized the new Quail Cottage for the first time in-between hikes to get a break from the rain, and some were lucky to find a few California newts on the Discovery Trail. We have more field trip days available at Quail Hollow Ranch in April and May, as well as for next school year starting in the fall.
