1. CALL TO ORDER / ROLL CALL Meeting called to order at 5:06 PM.

- 3. **ORAL COMMUNICATIONS** 3 members of the public.

Mariah Roberts: Executive Director of County Park Friends (CPF). Voiced concerns about the rezoning of County parcels that are being proposed to the Board of Supervisors and importance of the Commission being involved in conversations.

Lynn Dunn: Spoke to concerns about ADA compliance in the Live Oak Library Annex.

Cynthia Denny: Chair of the Sierra Club. Introduced herself to the commission and spoke briefly about the committee's hopes of being more active in the community and involved with the Commission.

5. COMMISSIONER REPORTS

<u>District 1</u>: Lots of communication happening in District 1. The issue of rezoning at Winkle Farm Park has come up. Lots of improvements in the local park and maintenance (bathroom painting, etc.).

District 2: Brand new to commission. Proud of progress made at the fields at Polo Grounds County Park.

<u>District 3</u>: Quiet, nothing to report.

<u>District 4</u>: Attended the Mesa Village beautification with Watsonville Wetlands Watch Participants got a fruit tree for participating, so there were around 60 people that attended. This volunteer event made the park more inviting.

District 5: Vacant

6. PARKS DIRECTOR'S REPORT

The Measure Q Citizens Oversight Advisory Board (COAB) will be meeting for the first time on Wednesday, April 16th at 5:30p. We had over 500 kids participate in Spring Break programs. Getting ready to do fuel reduction work at the Miller Property. We are recruiting for the Park Planner position, hoping to have that filled within the next 4-6 weeks. Working on adding new pollinator gardens at Felton Discovery Park and considering other parks to do the same. This would help reduce water usage and create pollinator habitats. Starting outdoor recreation program at Quail Hollow. The Parks team remodeled the cottage to be used as an outdoor education center. In April there will be a ribbon cutting for the Polo Grounds Score board. The Hidden Beach restrooms are expected to be completed/open in May. Parks Staff received recognition by CPRS. We have started developing the Pace Wilderness Property. Jody McGraw is assisting training staff/volunteers on trail developments. The artwork at Ben Lomond Transfer Station was approved by the Board of Supervisors. The artists is making a humongous fungus made of "reclaimed materials."

7. INFORMATION/DISCUSSION ITEMS

a. Presentation on Updated Parks Department Communications Plan – Sarah Shea, Parks Superintendent

Sarah Shea, Parks Superintendent, presented on the newly developed County Parks Communications Plan. The plan is still a work in progress, but it streamlines how and when information is shared with the public.

- **Commission Sanford**: What do you need from the Commission? Advocacy to Supervisors or support, etc? Getting the word out so the public knows where to find us and find information. Look at the Activity Guide and share the various programs with others.
- **Chair Konevich**: Does the department ever need help sourcing content? If you have an idea or story to share/highlight, please let staff know, so they can work to promote/share it and have feedback regarding what type of content others want to see.
- Commissioner de Sieyes: Suggested encouraging tagging County Parks on social media.

8. ACTION ITEMS

a. Discussion on the upcoming Santa Cruz County Board of Supervisors hearings to remove Park Designations for parcels in Santa Cruz County.

Director Gaffney discussed the proposed rezoning for 47 parcels of land, 5 of which are currently designated as Parks/Open Space. This is a Public Hearing item being presented to the Board of Supervisors on April 29th, 2025. The Parks Department and Commission were not consulted regarding the proposed parcels.

- **Commissioner Sanford**: *Is Brommer Street County Park becoming housing?* No, it's a parcel at 7th and Brommer St.
- Commissioner de Sieyes: Can you expand on the few acres at Par Three that will continue to remain open space/park land? There was a stipulation during the housing element that a previous district 2 Supervisor made sure that 2-4 acres of that parcel would stay public land (although it did not have to remain public land).
- **Commissioner Hernandez**: What can the Commission do moving forward? As a Commission, you could write a letter to the Board of Supervisors. Individually, you could talk to your District Supervisor.
- Chair Konevich: Asked for clarification between County Parks owning land and/or a Parks designation on a parcel near Winkle Park. County Parks owns the land adjacent to Winkle Park. The Par Three land is not County owned, but has a Parks designation, meaning it was intended to be developed into a park. If land is owned by Parks, how can it be taken away/changed? The land is owned by the County of Santa Cruz through the Parks Department. So the County can ultimately decide its use/designation. As the Planning team of the Parks Department is built up, should the Master Plan be revisited and what advice/direction do you have for the Commission to help move that forward? Becoming more engaged, meeting regularly with the Supervisor that appointed you, future meetings with Deputy Director Hurley. This would be a long-term project, so continuing to be engaged with the department and community.

Public comment: 4 members of the public.

- Chair Konevich: Do impact fees from development go to certain parks? Impact fees were updated in 2021-22 but were not able to be collected until recently so a backlog exists. The fees collected go all together in one "bucket" and are used throughout the County. The Board of Supervisors decides the spending of this money.
- Commissioner de Sieyes: Is the County's plan to rezone the parcel near Winkle Park and sell it to a
 developer for the Housing Element? There are many scenarios that could play out, but selling is a
 harder process.

Motion to have Chair Konevich and Commissioner de Sieyes write a letter, in collaboration with Parks staff, that conveys the Commission's concerns regarding rezoning parcels from Parks land: Sanford/**2**nd: Hernandez/All In favor

b. Review, discuss, and assign Commissioners to 2024-25 Commission Work Plan goals... pages 19-20.

Subject: Aquatics Section Report

From March to the present, the Aquatics Section has had strong participation across various programs. We have had 254 individuals enrolled in swim lessons, 83 participants in private lessons with our contractors, and 58 individuals in the ParkRx Free Swim Lesson Spring Program.

Since March, we have taught 4 lifeguarding classes. To end the spring season, we have certified 27 new lifeguards and recertified many of our current lifeguards. More than half of the participants have applied to work with us for the summer season.

As we finish up our spring hiring and gear towards summer, we have had 24 new lifeguard applicants and 2 new head guard applicants.

Throughout Spring we have maintained a 7-day-a-week schedule, providing consistent lap swim to the community. Lap swim is available Monday through Friday from 6:00 AM to 7:30 PM, and on weekends from 9:00 AM to 4:00 PM. In addition to lap swimming, we offer a variety of programs throughout the week, including Adult Fitness classes, Water Aerobics, and lane rentals for three local swim teams.

This summer, we are proud to offer a record number of spots in our pool guard programs. The Junior Guards program now has a total of 480 spots available, with increased availability in each session —100 open spots in each morning session and 60 in each afternoon session. Additionally, our Little Guard program has expanded to offer 192 total spots, marking the highest capacity ever for our summer camp programs.

We recently hosted our first-ever Family Glow Night Pool Party, which was a major success with over 200 attendees enjoying an evening of swimming, music, glowing accessories, and community fun. Additionally, we are excited to offer our next event: a Family Movie Night at the Pool, featuring the film *Luca*. There are 200 spots open for registration, and the evening will include popcorn, snacks, and a food truck on-site. These family-friendly events have been very well received, and we are committed to continuing to create fun, engaging, and creative experiences for families at the pool throughout the summer.

We are offering three Free Family Swim Days this summer on Memorial Day, the 4th of July, and Labor Day, providing more opportunities for the community to enjoy a fun day at the pool at no cost.

Percent for Art Public Art Projects

Juvenile Hall - The County Arts Commission will review the selection panel's recommendation of public artist for the Juvenile Hall Facility on May 5. If approved by the Commission, the artist's proposal and agreement will go to the Board of Supervisors for their consideration.



Shaun Logan was selected as the public artist for the new restroom building at **Hidden Beach** Park. The artist's proposal includes two components. The mural features what a park visitor might see as they make their way down the path to the beach: Monterey Bay, the seawall, flowers, a breaking wave, foliage and a songbird. He also designed way-finding signs to direct park visitors to the beach, and beachgoers to the restroom facility. The mural will be completed by May 7.

Justin Francavilla is busy creating public artwork for **Floral Park**, to be installed this spring near the new playground. The "Life of the Tide Pool Party" will feature tide-pool dwelling creatures on two bronze

sculptures, one a plaque, the other a 3-dimensional piece. Infused with whimsy, the design will include elements such as sea stars embracing each other alongside some underappreciated sea neighbors like nudibranchs, snails, and barnacles -- all of which can be found just one block away in the world-renowned Pleasure Point tide pools. The plaque will offer park visitors the opportunity to make a rubbing of the artwork with crayons and paper, taking their own copy of the art home.

Mary Tataro was recently approved as the public artist for the **Ben Lomond Transfer Station.** "Humungus Fungus" will feature nine mushroom-shaped sculptures of welded metal covered with steel mesh, fiberglass cloth, and resin, then overlaid with weather-resistant reclaimed materials. The sculptures will be painted and finish-coated to protect against the elements. Placed in groups of three, the mushrooms – nature's recyclers - will range in height with the small ones 4-5 feet, the medium 5-7 feet, and the large 9-12 feet.

Santa Cruz County 2025 Artist of the Year

Janet Rachel Johns, dancer and choreographer, has been named 2025 Santa Cruz County Artist of the Year by the Santa Cruz County Arts Commission. Please join us at 7:00 p.m. on Friday, May 9 at the Crocker Theater, Cabrillo College for a *Profile Performance* featuring Janet and Esperanza del Valle. Admission is FREE to the public; seating is limited and available on a first-come, first-served basis the night of the event.



As an Assyrian woman, mother, educator, dance instructor, choreographer and a performing artist in Santa Cruz County for over 45 years, Johns has experienced firsthand the power of the arts for healing a community and bringing people together. Since she started learning folklorico dance at age 18 as a university student at San Jose State University, she learned from her mentor, Ramon Morones Ortiz, of Guadalajara, Mexico, the importance of learning authentic steps, style and choreography from master instructors and keepers of the

traditions of Mexico. When she moved to Watsonville to begin her career as a bilingual educator in 1978, she co-founded Esperanza del Valle and wrote her first Arts Council grant, establishing her folklorico dance class as a performing company in 1980. Esperanza del Valle was the only adult folklorico dance company in the Watsonville community in those early days. Hundreds of dancers have trained, learned, and performed with her company over 44-plus years.

Subject: Maintenance Section Report

North County

- Pace Trail Project Quail Hollow Ranch: Ongoing maintenance and volunteer coordination efforts are actively supporting the continued development of the Pace Trail at Quail Hollow Ranch. Volunteers and staff are working collaboratively to improve trail conditions and enhance user experience.
- Miller Property Boulder Creek: Construction of a new parking area has commenced at the Miller Property in Boulder Creek. This project aims to improve public access and accommodate increased visitation while preserving natural surroundings.
- **Equipment Acquisition:** The maintenance division has acquired a new excavator, along with a forestry mulching head attachment designed for our tracked skid steer tractor. This new equipment will significantly increase our capacity for vegetation management, land restoration, and trail maintenance activities.
- Seasonal Grounds Maintenance: Routine springtime operations are underway, including mowing, invasive weed control, and general landscape upkeep across all managed properties to ensure safety, accessibility, and environmental stewardship.

Mid County

- Relocation of Mid-County Operations: The mid-county maintenance team is in the process of relocating its operations from the Simpkins Family Swim Center to the garage and office facilities located on Felt Street. This move is intended to consolidate operations, improve logistical efficiency, and better support ongoing fieldwork in the region.
- Turf and Field Maintenance Jose Avenue and Brommer Park: Maintenance crews continue to
 perform essential turf management and field upkeep at Jose Avenue Park and Brommer Park. These
 efforts include irrigation checks, turf rehabilitation, aeration, and general grounds maintenance to
 ensure high-quality, safe recreational spaces for public use.
- Swim Center Facility Repairs: The showers in the locker rooms at the Simpkins Family Swim Center
 are currently undergoing repairs to address plumbing issues and improve user comfort. Work is being
 conducted with minimal disruption to facility operations and is expected to be completed promptly.

South County

- Seasonal Grounds Maintenance: Spring maintenance activities are underway at all South County
 Park locations, including mowing, weed abatement, and landscape management. These efforts are
 essential for maintaining the safety, appearance, and ecological health of our public spaces during the
 growing season.
- Sports Field Maintenance Aptos Polo Grounds and Pinto Lake: Routine sports field maintenance continues at both Aptos Polo Grounds and Pinto Lake County Park. Crews are focused on turf care, surface leveling, and irrigation system checks to ensure fields remain in optimal condition for community use and scheduled athletic programs.
- Restroom Installation Hidden Beach: Maintenance teams are supporting the recent installation of a new public restroom facility at Hidden Beach. Associated site work includes utility connections, pathway adjustments, and landscaping to integrate the structure with the surrounding environment.
- Facility Upkeep Aptos Village Park Clubhouse: Ongoing facility maintenance and repairs are being carried out at the Aptos Village Park Clubhouse. Tasks include structural assessments, minor repairs, and general upkeep to ensure the building remains functional, clean, and welcoming for community events and rentals.

Coastal Rail Trail

<u>Segments 10 and 11</u>: The Capitola City Council voted not to approve the Park Ave alignment at a special City Council meeting on April 17 and requested that the trail remain in the rail corridor, which is consistent with the alignment of the Ultimate Trail Configuration previously approved by the Board of Supervisors on April 30, 2024.

An amendment to the existing consultant contract to add final design was recently approved by the Board on April 29, 2025. Final design for the project will kick-off in early May, and will start by modifying the design to incorporate suggestions from the RTC-led value engineering study conducted in 2024. Updated designs and cost estimates for the project are expected in late Summer.

Ecology Action is continuing to lead the non-infrastructure programming portion of the project, coordinating with 10 area schools on bicycle and pedestrian education classes, and the creation of a community incentive program that will target low-income monolingual Spanish speaking residents of Live Oak, Pleasure Point, and Capitola. Additional pedestrian and bicycle classes at area schools are scheduled for 2025.

North Coast Rail Trail (Segment 5): The RTC expects to open the Panther/Yellowbank parking lot to the public this summer prior to the rest of the project opening in Summer 2026. The purpose of the early opening of the parking lot is to minimize impacts to public coastal access. The trail itself will not be open. As part of the Maintenance Agreement for the project, County Park and Public Works will be maintaining the trail on behalf of the RTC. An addendum to the Maintenance Agreement will need to be approved by the Board of Supervisors and RTC to have Parks staff begin early maintenance of the parking lot.

Floral County Park Playground Renovation


Site work, drainage modifications and landscape modifications have been completed; play structure and PIP have been installed. The project was completed in Winter 2024. The Public Art piece will be finished in Spring 2025.






Freedom Lake Restoration Plan

Freedom Lake, a cherished natural resource for both wildlife and the community, has faced challenges from invasive species that disrupt native habitats and diminish water quality. In a series of workday events, dedicated teams from Watsonville Wetlands Watch and the California Conservation Corps worked side by side to remove invasive trees and plants that are impairing native habitat and obstructing the open viewing and access routes of park users. Consistent with best practices for riparian habitat and vegetation management, willow trees were pruned and limbed up to reduce hazards for park users and enhance lines of site and the feeling of openness to enhance park user safety. During the winter rains approximately 100 native understory plants and shrubs are being planted within the Acacia removal areas to increase diversity of native plants growing on site and improve the park user experience. Phase 2 for this project, including a series of planning studies and analysis will be performed in coordination with staff from Santa Cruz County Parks and other resource professionals in the region, is expected to commence in late Spring 2025.





Greyhound Rock

Parks staff are finalizing consultant contracts to conduct an initial feasibility study that will analyze the potential for biological, geological, and cultural constraints for the cabin project. This feasibility study will identify suitable development locations for the environmental education center and cabins. Results of the initial feasibility study are expected in Late Summer 2025.

Hidden Beach County Park

Site Prep Work for construction of the project started in January. The permanent, prefabricated, ADA-compliant double-unit restroom was delivered on-site on February 26th. Site Work including final utility connections, parking lot modifications, ADA path of travel and landscape modifications is scheduled to be completed by April 30th. The mural in the building part of the public art is currently in progress. The project is expected to be completed in Spring 2025.





Moran Lake County Park

Monarch Butterfly Habitat Management Plan: County Parks, in collaboration with the Santa Cruz County Sanitation District and the First District Supervisor, recently completed a wind study for the Moran Lake monarch habitat in response to community feedback. The wind study analyzed the effects of the tree canopy on wind protection for monarch overwintering sites and identified tree management actions that could be taken to reduce the risk of tree failure while protecting monarch habitat. The draft wind study is available on the County Parks website for public review, and viewable at the link below:

Based on the data from the wind study, County Parks will be starting tree trimming and tree removal work around Moran Lake County Park in mid-May to improve public safety and ensure the long-term viability of monarch overwintering habitat. The upcoming tree work is science-based and is part of Parks' ongoing efforts to manage monarch habitat at Moran Lake and increase climate resilience. Any trees removed will be replaced with native tree species that support local biodiversity and monarch habitat, similar to the 64 native trees that were planted in December 2024.

A community meeting to discuss the results of the wind study and how that relates to the monarch habitat management plan will be held in June, date and time TBD.



Pace Property Connection Trails

Pace Property Trails will bring residents through the sandhill habitat, one of the rarest ecosystems in the United States and found only in Santa Cruz County. Project trail layout and flagging have been completed with great interest from the community. Park staff have coordinated directly with the biologist and trail design consultant in refining the trail layout. Park staff and the project biologist have collaborated in creating the worker environmental awareness training program. The training is required for all workers and volunteers associated with



construction on the trail and was held in February. The topics covered were construction best management practices and biological resource protection measures, including the special status species that reside in the sandhill habitat. The project biologist has submitted the permitting requirements for the project with U.S. Fish and Wildlife Service. Trail construction will be a coordinated effort between Parks staff, the trail design crew, and local volunteers. With an estimated volunteer percentage of 35%-45% for the trail construction. Trail construction in the sandhill habitat area will have to occur outside of the Mount Hermon June beetle flight season from May 15 to August 15, and bird nesting survey will be performed prior to the spring construction. Park staff will be working with volunteers late spring to clear invasive broom and begin construction on the loop trail outside of the sandhill habitat.





Santa Cruz Coastal Lagoons & East Cliff Drive Resiliency Study

County Parks was awarded a \$650,000 grant from the State Coastal Conservancy to develop an initial planning-level feasibility study of nature-based adaptation strategies to sea level rise for East Cliff Drive at the three coastal lagoons (Schwan Lagoon, Corcoran Lagoon, and Moran Lagoon) in mid-Santa Cruz County. The goal of the project is to identify a preferred adaptation strategy for each location that prioritizes nature-based solutions, protection of coastal resources and ecosystems, maintenance of coastal access, and protection of infrastructure and property.

An RFP for consultant support for the project was released on January 6. The County received three proposals from highly qualified consultant teams. A selection committee comprised of staff from the Coastal Conservancy, California State Parks, County Public Works, and County Parks evaluated the proposals, conducted reference checks, and interviewed the consultant teams and selected Environmental Science Associates (ESA) as the top-ranked consultant team. Staff has begun negotiations on scope and fee with the top-ranked consultant team, and if those negotiations are successful, staff expects to bring a contract to the Board for approval in May/June.

South County Parkland Acquisition - Whiting Road

A preliminary park diagram for phase 1 was developed by County Parks while a permanent plan is developed. The diagram was shared previously with the Commission. Funds have been allocated for phase 1 implementation and staff are coordinating the required access improvements to scope out the Phase 1 work. Partial funding for Master Plan development has been allocated from the District 4 Supervisor's office, more funds are required to develop the Master Plan.
