- Margit Aramburu: I am very excited to be the new Secretary for Friends of Santa Cruz County Parks. The timing was right. I was involved with advocacy for Seacliff Village Parks, as well as Seascape Park and I look forward to serving FSCCoP.

PARKS, BUILDING, AND GROUNDS MAINTENANCE

NORTH COUNTY PARKS (Highlands, Ben Lomond, Felton Covered Bridge, Probation, Michael Gray Field, Quail Hollow Ranch and the North Coast)

Staff are working thorugh the FEMA process to get funding and make repairs to storm damaged parks. Staff hope to have a section of Ben Lomond Park opened soon.

Staff prepared the athletic fields at Michael Grey field and Highlands park for opening day of baseball.

The Americorp team did a week of non-native plant removals at the future Felton Library site. Volunteers led by the Valley Women's Club, Environmental Coordinator, Linda Skeff are continuing efforts to make improvements to the site.

MID-COUNTY PARKS (AJC, Government Center, Emeline Complex, Twin Lakes, Brommer, Felt, Floral, Coffee Lane, Soquel Lyons, Jose Avenue, Winkle Farm, Willowbrook Lane, Moran Lake, Maplethorpe, Santa Cruz Gardens, Heart of Soquel Plaza, The Farm, Mid-County beach access areas)

Clean up, tree removals and assessments are continuing at Moran Lake Park. Staff are working with an arborist and butterfly specialists to further reduce any tree hazards.

Staff repaired a fence that was damage by a falling tree at Floral Park.

Staff are working with the Water Conservation Coalition and Ecology Action to participate in a Lose your Lawn workshop at the Emeline Campus on April 15th.

SOUTH COUNTY PARKS (Polo Grounds, Valencia Hall, Hidden Beach, Seascape, Aptos Village, South County Beach access areas, Scott Park, Scott Estate, Aldridge Lane, Mesa Village, Pinto Lake, Freedom Government Annex, Seacliff Village Park)

The old stairway leading to the creek area at Aptos Park has been removed. Staff hope to replace it before summer.

Park staff removed and replaced failing concrete areound one of the picnic pavilions at Pinto Lake Park.

Staff have begun out spring mowing at our undeveloped park site and usndeveloped areas of current parks. Pinto Lake Parks, Seascape Park and the 'Crestview' lot were mowed this month.

SIMPKINS FAMILY SWIM CENTER

A new hot water heater was installed in the kitchen at the **Simpkins Family Swim Center**. The previous hot water heating system did not provide a hot enough temperature to meet code conditions for a commercial kitchen.

All maintenance staff received training on the topics of Bloodborne pathogens.

RE: Facilities Division Status Report- March/April 2017

Summary for reservations and Facilities operations in the Parks (excluding SFSC):

Attendance at Reserved Facilities:

March and April have seen an increase in use of reservable areas with parties, weddings, memorial services and sports taking place at park centers, picnic areas and athletic fields. Staff estimates that approximately 59,500 park visitors attended events in reserved facilities at County Parks in these two months, an increase of over 50,000 from January and February attendance.

Center and Meeting Room Rentals in March and April 2017:

March and April hosted 19 weddings, receptions and family events held at various Park Centers with rental revenues totaling \$17,850. 54 meeting room rentals also took place during these two months, with revenues totaling \$1,720.

Picnic Area Rentals in March and April 2017:

Use of the reservable picnic areas have increased during the months of March and April, with 43 rentals for parties and family events taking place so far, as compared to 14 rentals that took place in January and February. Anna Jean Cummings picnic areas continue to book months in advance and typically rent to capacity on weekends each month. Revenues for March and April total \$6,450.

Athletic Fields in March and April 2017 (includes February info for baseball fields):

The season for athletic field use began late February for baseball and softball fields, while soccer fields were opened between the end of March and beginning of April in an effort to provide for a longer renovation period. The athletic season is now in full swing and has become very busy, for both baseball and soccer fields, with 679 individual field bookings in 18 athletic fields (504 bookings in baseball fields and 175 bookings in soccer fields). Revenues totaled \$39,200.

Special Events:

The special event season has kicked off during these past few months with a number of events having already successfully taken place. Fleet Feet Sports hosted the Diocese of Monterey Health Challenge 3K at Anna Jean Cummings Park on March 11th. It was the first event of its kind at Anna Jean and was very successful. April events include: Coast Chapel will host the second annual free Easter Egg Hunt for the community at Brommer Street Park on April 15th. Activities include a free BBQ, jump house, and photos with the Easter bunny. Earth Day on April 22nd will take place at the San Lorenzo Park and include use of the back and south lawns of the Government Center as well as the parking lot for festival parking. Team in Training/ Leukemia & Lymphoma Society will host the Spring Fun Run for Team Coco at Pinto Lake County Park on April 22nd. This race commemorates the birthday of Coco Lazenby, a civic-minded, young community activist, who was killed by a distracted driver in 2015. Aptos Park will host Mar Vista Elementary's second annual Move For Mar Vista on April 23rd. The inaugural Run.Sweat.Love. 5k Fest, benefitting Mini Mermaid Running Club & Young Tritons, will take place at the Polo Grounds, for a first time entire park rental which anticipates attendance of up to 1500 local youth participants. The Big Stick Surfing Association will host the annual Big Stick Log Jam retro surf board contest at Pleasure Point Park on April 29th and 30th, which fundraises for the community and ocean-focused non-profits. 2017 is proving to be another busy year of special events.



Swim lessons – spring lesson are held on Tuesday and Thursday mornings from 10:30am – 12:30pm; Monday/Wednesday/Friday and Tuesday/Thursday evenings from 4:00 – 7:00 pm.

Summer Program Registration starts March 27 at 9am and the Junior Guard and Little Guard programs are anticipated to fill up quickly!

Water Polo - Sundays from 10:30 am - 12:30 pm. Participants must be a member of USAWPA to participate in the program.

Spring Break Pool Junior Lifeguard Program – The Spring Break Pool Junior Lifeguard Program will be running April 3 - 7 at Simpkins Family Swim Center, Mon – Fri from 9:00 am – 2:00 pm with the option for participants to stay for Recreation swim from 2:00 – 5:00 pm free of charge. The spring program follows similar schedules and activities as our very popular Summer Pool Junior Lifeguard Program and has a special activity day on the last day.

Lifeguard Training Classes - Lifeguard Training Classes are being offered and will continue through the end of April. Most classes will be held on Friday evenings and Saturdays; fees are \$310 for residents and \$341 for non-residents. As well, Simpkins Family Swim Center will also be offering limited courses in First Aid for Public Safety Personnel (CA Title 22). Interested candidates can find more information on the parks website at www.scparks.com. All course materials are included in the course fees.

Aquatic Staff Recruitment

The following positions are currently open; Lifeguard, Head Lifeguard, Aquatic Specialist. The recruitment ends April 21st.

Private Pool Parties – Private Pool Parties are available on Saturdays & Sundays. A variety of aspects of the facility may be rented for Private Pool Parties, from just the warm pool to aspects accommodating up to 110 people. Private Pool Parties are scheduled on weekends, spring, summer and fall, after the facility has closed to the public.

School Parties – Once again local schools will be renting the facility for their end of the year parties starting the last week in May and continuing into June.

Adult Fitness Swimming - Adult Fitness Swimming is very popular at the Simpkins Family Swim Center. The best-attended workouts are Tuesday and Saturday mornings; up to 35 swimmers fill the 50-meter pool at these times. Fitness swimmers may choose from several different workout times: Monday's 6:00 am; Tuesday, Wednesday, Thursday and Friday workouts are at 6:00 a.m. and 12:00 p.m.; Saturday and Sunday at 9:00 a.m. Starting in March we also have begun to offer a Saturday afternoon class every other Saturday which has so far been well attended.

For the past two months we have been offering an Introduction to Lap Swimming Class and an Introduction to Adult Fitness class on Wednesday and Thursday mornings which have continually gained attendance numbers. Beginning in April we will be offering an Introduction to Lap Swimming Class on Saturdays so swimmers that work during the week can take advantage of this great class.

Water Aerobics & Exercise - The water exercise classes this year continue to reach their highest capacity to date. Water exercise is an excellent way for people to meet their fitness goals without impact on the joints. Classes are designed to appeal to all levels of ability including, healthy, pre-natal, seniors, and rehabilitating or cross training fitness enthusiasts. A monthly calendar is available with dates, times and instructors names. Previous swimming or water-exercise experience is not required for participation in any of the water exercise classes.

Lifeguard Training Exercises -

The lifeguard in-service in March was a swim condition check; shallow water spinal rescues, and a swim lesson review.

In April the topics scheduled to be covered are:

Emergency action plans

In May the topics scheduled to be covered are:

Victim recognition, skills review, and pool rules discussion.

Swim Teams - The Aptos Cabrillo Swim Club and Santa Cruz County Aquatics - CRUZ - swim teams continue to rent lanes in the 50-meter pool. The swim teams offer school-age competitive swimming programs Monday through Friday from 4:00-7:30 p.m.

Pool Closures and Holiday Schedule

There are no scheduled pool closures in April, June, or July.

Live Oak Community Rooms - The Live Oak Community Rooms at the swim center are rented out regularly throughout the year for meetings, small events and classes.

COUNTY-WIDE PROJECTS

County Parks Strategic Plan: Staff has continued progress on the development of a Strategic Plan for the County Parks Department. Staff has completed three large group meetings with Department staff to get input on the process, and has compiled a draft summary on the existing conditions and Department needs. Staff has scheduled five community meetings for the last week of April through the second week of May, and has developed an extensive publicity and outreach program for these meetings.

Park Finder Map: Staff has worked with the County GIS Department to put an interactive Park Finder map on the Parks webpage.

NORTH COUNTY PARKS (Highlands, Ben Lomond, Felton Covered Bridge, Probation, Michael Gray Field, Quail Hollow Ranch and the North Coast)

Quail Hollow/Pace Property Trail Planning: County Real Property staff is working with the property owner on the potential for a trail easement allowing a proposed new trail from Quail Hollow Ranch to the Pace Property. County Parks staff went on a site visit with the biologist preparing a biotic assessment to be used for the project.

Felton Library: Parks staff continues to work with other County staff to develop the site plan for the new Felton Library and an outdoor nature explore play area on the library grounds.

MID-COUNTY PARKS (AJC, Government Center, Emeline Complex, Twin Lakes, Brommer, Felt, Floral, Coffee Lane, Soquel Lyons, Jose Avenue, Winkle Farm, Willowbrook Lane, Moran Lake, Maplethorpe, Santa Cruz Gardens, Heart of Soquel Plaza, The Farm, Mid-County beach access areas)

Brommer Park: Planning staff is working with Parks Maintenance staff who will be managing the contractor installing four pickleball courts and resurfacing the courts at Brommer Park.

Chanticleer Avenue Park: The County was notified that National Parks Service will be awarding the Land Water Conservation Fund grant to the Parks Department for \$500,000 towards the development of Phase I at Chanticleer. The Parks Department has a purchase order set up to do additional

geotechnical borings to assess feasibility of a groundwater recharge drywell system at the park. The Santa Cruz Playground Project has continued their fundraising efforts.

Staff submitted a grant application to the Housing-Related Parks program for funds for Phase 1 development at Chanticleer. Staff is preparing a grant application for the Tire-Derived Products grant program for resilient surfacing at LEO's Haven.

SOUTH COUNTY PARKS (Polo Grounds, Valencia Hall, Hidden Beach, Seascape, Aptos Village, South County Beach access areas, Scott Park, Scott Estate, Aldridge Lane, Mesa Village, Pinto Lake, Seacliff Village Park, Freedom Government Annex)

<u>Polo Grounds Restroom</u>: A railing has been installed at the restroom and striping at the ADA parking spaces is being fixed.

<u>Pinto Lake</u>: Staff is working with the Resource Conservation District (RCD) on a project to add rolling dips on the road near where the virgin tree used to be located for sediment and erosion control.

North County

County Park Advisory Commission Meeting 5 December 2016 Comments on Agenda Item #2 by Michael Lewis and Jean Brocklebank

As a rule, By-laws should be simple, general, concise, and without minutia. For instance, the words Santa Cruz do not need to be added (a proposed amendment throughout the latest revision) to existing By-laws for a Santa Cruz County advisory body. It is understood that the bylaws are for a Santa Cruz County body. Nor does the acronym POSCS in parentheses need to be added.

As the past 4 months worth of Commission meetings have demonstrated, amending By-laws is tedious and therefore amendments should be rarely implemented, **without a compelling reason**.

Even when a County policy changes, the By-laws do not necessarily need to be formally amended. For instance, due to budget constraints, when all County advisory commissions were reduced to meeting every other month, this did not necessitate amending By-laws of all those commissions to match the reduced meeting allowances. The commissions simply adapted to the new schedule.

Each amendment to the By-laws for the Parks Commission will entail <u>administrative time</u> -- time taken from County Counsel, time taken from Board of Supervisors staff, time required by Parks staff. If an amendment is not necessary, let's not burden the County with time consuming work. Some examples include:

Sec. 7 Hyphenating subcommittee throughout this section is unnecessary.

Sec. 13 There is no compelling need to change on death to with death; no need to change anything in this section

Sec. 14 A There is no compelling need for the added sentences - Biennial means every two years!

Additionally, those Powers and Duties as established for the Parks Commission by <u>County Code</u> <u>Chapter 2.70.050</u> must not be amended in any way. These sections have to remain *in compliance with* County Code. This Commission is <u>not authorized</u> to recommend amendments to Santa Cruz County Code.

With the foregoing in mind we make the following **recommendations**:

- Scrap entirely the December 5 revisions.
- Return to the October 3 revisions.
- Retain Sections 1 6 unamended (with one correction, see below**)
- Amend only Sections 7, 10 A, 10 D
- Add Section 15 and 16 (see below)

** The original Parks Commission By-laws had an unfortunate typo. In Section 6 C the word master was typed as "matter." In the matter plan, not in the master plan -- as stipulated in County Code 2.70.050. While this typo in no way changes the Powers and Duties of the Commission, if it is troublesome to be reminded of the original typo, the word can be corrected. But it is not an amendment to the By-laws.

15) Amendments

Amendments to these By-laws may be recommended to the Board of Supervisors by a majority vote of the commission.

16) Approval of By-laws


These By-laws, and any subsequent amendments thereto shall be approved by the Board of Supervisors pursuant to the County Code Section 2.38.140.


2017 Winter Storm Damage at Corcoran Lagoon Beach Report to Parks Department and Parks Advisory Commission




On January 29 & 30, two residents associated with Friends of Corcoran Lagoon Beach (FoCLB) alerted Parks to the garbage bins that were flushed into the inner lagoon during one of the major winter storms of this season. We also knew that one of the signs (replaced after the 2015/16 winter storms) was missing. Here are pictures of the sign, floating in the inner lagoon, taken (1/21/17) by a third resident and member of FoCLB. When the sign was retrieved by another resident, it was placed by the side of the road, then disappeared. We hope County workers got it.





Although Gretchen responded immediately to the 1/30 alert, saying that they would get the bins, the garbage bins were actually retrieved on January 31st by a resident unknown to FoCLB). An hour later County workers, also unaware that a resident had retrieved the bins, showed up with a boat to find the bins back in place. Here are pictures of that retrieval:





We are very pleased to learn that our suggestion that Parks be proactive, when these huge storms are predicted, has been taken to heart. By removing the garbage bins ahead of the extreme conditions forecasted, garbage (including a lot of plastic bags of dog feces) will not end up in either the lagoon or flushed back out into the Monterey Bay National Marine Sanctuary due to natural tidal action.

We hope that parks will give some serious management consideration of all County beach access conditions, as this pollution may have been a problem at other County beach access locations. We look forward to seeing this management concern incorporated into the now-developing Strategic Plan for the Department.

Additionally, last year FoCLB initiated conversation with County Public Works Director John Presleigh (copied to Parks Director Jeff Gaffney) about the need to seriously explore replacing the section of E. Cliff Drive (that bifurcates the lagoon and beach and floods every year) with a causeway. Such a causeway would allow more natural tidal action, during annual destructive winter storms. The benefits of a properly designed and built causeway would include:

- reduced environmental damage due to garbage pollution of spilled bins.
- · less money spent on maintenance to haul sand off the roadway
- · eliminate flooding and closure of E. Cliff Drive
- eliminate the constant replacement of beach access signage
- allow the lagoon system to absorb wave energy with less destruction
- allow the shorebird nesting area of Corcoran Lagoon Beach to fluctuate with a more naturally functioning lagoon

We are aware that the County has many unfunded needs for maintenance and replacement of poorly designed roadways and that funding is always a challenge. At some point, however, coastal problems will have to be addressed. Destruction by severe winter storms is not going to go away and may even get worse in the coming decades.
